Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the road and sides of road identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on **XXXX 2024** and may be cited as Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2024 [Prohibition of Waiting on Bradley Drive, Malvern].

Description of the map

The map shows the proposed the proposed prohibition of waiting zones on Bradley Drive, **Malvern**: -

Leigh Sinton Road (west side) from its junction with Bradley Drive for a distance of 17m in a northerly direction and 15M in a southerly direction.

Bradley Drive (north side) from its junction with Leigh Sinton Road for a distance of 23m in a westerly direction.

Bradley Drive (south side) from its junction with Leigh Sinton Road for a distance of 23m in a westerly direction.
