Description of the map

The map shows the Prohibition of Waiting on Seaford Lane and Orchard Lea, **Naunton Beauchamp: -**

Seaford Lane (West side): From its junction with C2225 for a distance of 30 metres in a south easterly direction.

(East side): From its junction with C2225 for a distance of 26 metres in a south westerly direction

Central triangle: The entire perimeter, a distance of 43 metres

Orchard Lea (Both sides): From its junction with Seaford Lane for a distance of 10

metres in a westerly direction
