Description of the map

The map shows the proposed Prohibition of Waiting zone on Broad Street/Duke Street, Kidderminster: -

Broad Street (south west side)- from its junction with Duke street for a distance of 16m in a southerly direction and 8m in a northerly direction.

Duke Street (south east side)- from its junction with Broad street for a distance of 10m in a western southerly direction.

Duke Street (north west side)- from its junction with Broad street for a distance of 10m in a western southerly direction.
