Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

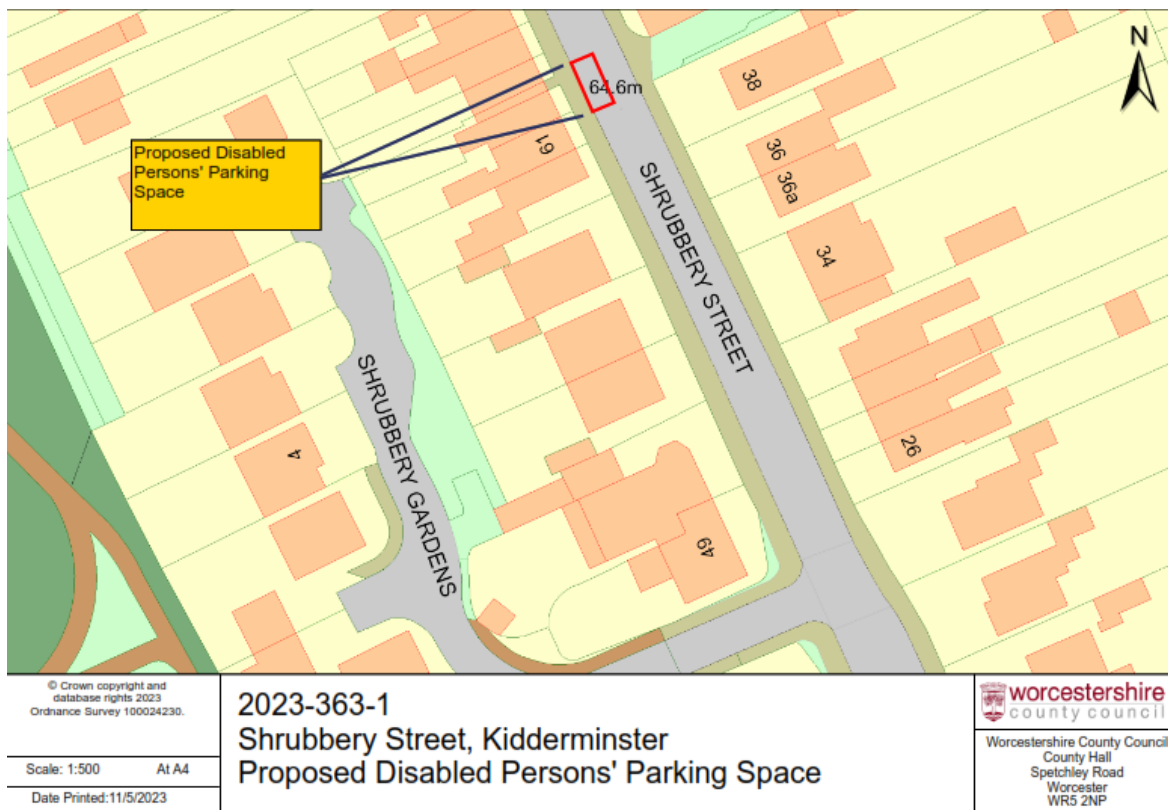


Map and plan of the area

Description of the map

The map shows the disabled persons' parking place zone on Shrubbery Street, Kidderminster: -
Shrubbery Street From a point, 80m northwest, from its junction with Shrubbery Gardens, for a distance of 6.6m **and** from a point 68.5m, for a distance of 6.6m, both in a southeast direction.
