Worcestershire County Council in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (which said Act is herein after referred to as 'the Act of 1984') and Part IV of Schedule 9 to the Act of 1984 and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. That The Worcestershire County Council (Various Roads Droitwich, Hampton Lovett and Cutnall Green) (30 Mph and 40 Mph Speed Limit) (Revocations and Proposals) Order 2019 is hereby revoked in its entirety.
2. No person shall drive or cause or permit be driven any motor vehicle at a speed exceeding 30 miles per hour along those roads as specified in Schedule 1 to this Order.
3. No person shall drive or cause or permit be driven any motor vehicle at a speed exceeding 40 miles per hour along those roads as specified in Schedule 2 to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
4. This Order may be cited as Worcestershire County Council (Various Roads Droitwich, Hampton Lovett and Cutnall Green) (30 Mph and 40 Mph Speed Limit) (Revocations and Proposals) Order 2019 (Revocation) and Various Roads, Droitwich, Hampton Lovett, and Cutnall Green, (Restricted Roads and 40 MPH Speed Limit) Order 2024 and shall come into operation on 30 May 2024.



4. This Order may be cited as Worcestershire County Council (Various Roads Droitwich, Hampton Lovett and Cutnall Green) (30 Mph and 40 Mph Speed Limit) (Revocations and Proposals) Order 2019 (Revocation) and Various Roads, Droitwich, Hampton Lovett, and Cutnall Green, (Restricted Roads and 40 MPH Speed Limit) Order 2024 and shall come into operation on 30 May 2024.

C2085 Addis Lane from its junction with A442 for a distance of 655 metres in an easterly direction.

C2143 from its junction with A442 for a distance of 420 metres in a westerly then south westerly direction.

UC40008 Elmley Close for its entire length.

UC40009 for its entire length.

UC40410 Oak Tree Drive for its entire length.

The 40mph speed limit on the following lengths of road in **Cutnall Green**, as follows:

A442 Droitwich Road from a point 150 metres north of its junction with C2018 in a southerly direction to a point 580 metres south of its junction with C2143.

C2018 Clattercut Lane from its junction with A442 for a distance of 60 metres in a northerly direction.

UC40405 Foster Drive for its entire length.

The 40mph speed limit on the following lengths of road in **Droitwich and Hampton Lovett**,

A442 from its junction with A38 Roman Way in a generally northerly direction to a point 200 metres north of its junction with C2074 Doverdale Lane.

C2254 from its junction with A38 Roman Way in a south easterly direction to a point 70 metres north west of its junction with UC41202 New Chawson Lane.

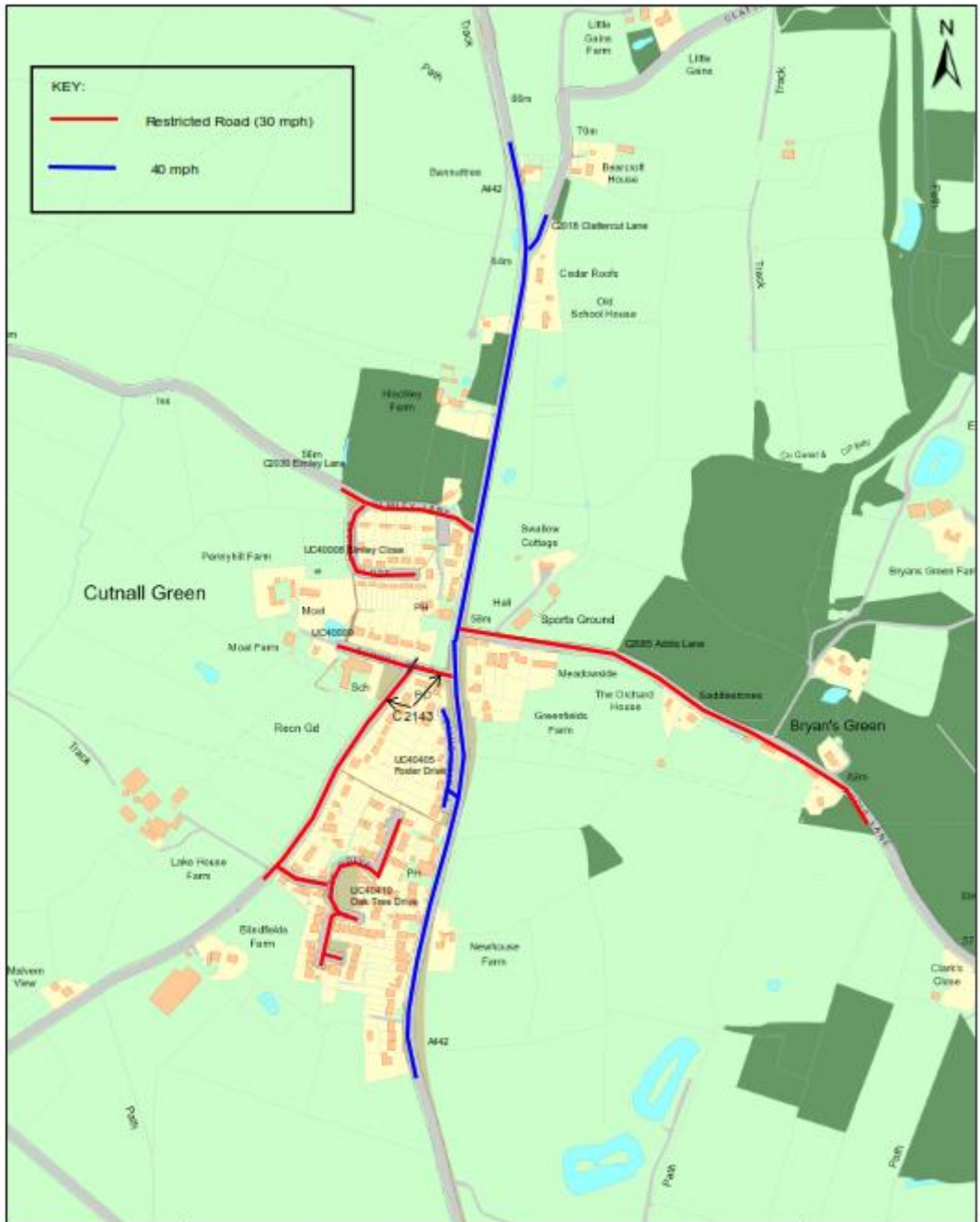

2. No person shall drive or cause to be driven any motor vehicle at a speed exceeding 30 miles per hour along those roads specified in Schedule 1 to this Order.
3. No person shall drive or cause to be driven any motor vehicle at a speed exceeding 40 miles per hour along those roads specified in Schedule 2 to this Order.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
5. The Order shall come into operation on 7 March 2019 and may be cited as Worcestershire County Council (Various Roads, Droitwich, Hampton Lovett and Cutnall Green) (30 mph and 40 mph Speed Limit) (Revocations and Proposals) Order 2019.
