Description of the map

The map shows the prohibition of waiting and restriction of waiting zones on Weir Lane, **Worcester.**

<u>Weir Lane</u> (North side): from a point 43 metres east of its junction with Bromwich Road for a distance of 74 metres in an easterly direction;

(South side): from its junction with Weir Lane (western access road) to its junction with Weir Lane (eastern access road).

<u>Weir Lane (western access road) (Both sides):</u> from its junction with Weir Lane for a distance of 10 metres in a southerly direction.

And to restrict waiting Mon-Sat 8am-5pm

<u>Weir Lane</u> (South side): from a point 59 metres east of its junction with Bromwich Road for a distance of 13 metres in an easterly direction,
