Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (DISTRICT OF WYCHAVON – DROITWICH AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2004 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON BLACKFRIARS AVENUE, DROITWICH]

Worcestershire County Council propose to make an Order for facilitating the passage on the road or any other road of any class of traffic.

ROAD TRAFFIC REGULATION ACT 1984 WORCESTERSHIRE COUNTY COUNCIL (DISTRICT OF WYCHAVON – DROITWICH AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2004 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON BLACKFRIARS AVENUE, DROITWICH]

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 3 (1), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (District of Wychavon – Droitwich Area) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the length and sides of road identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXXX 2024 and may be cited as Worcestershire County Council (District of Wychavon – Droitwich area) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 (Variation) Order 2024 [Prohibition of Waiting on Blackfriars Avenue, Droitwich]
