Map of Crown Street, Summer Street and Raglan Street, Worcester and the prohibition of waiting zones implemented by the above order.

Description of the map

The map shows the prohibition of waiting zones on Crown Street, Summer Street and Raglan Street, **Worcester:-**

Crown Street (north side) from its junction with Summer Street for a distance of 10 metres in an easterly direction.

Summer Street (east side) from its junction with Crown Street for a distance of 9 metres in a northerly direction.

Raglan Street (west side) from a point 24 metres south of its junction with Gregory's Mill Street for a distance of 7 metres in a southerly direction.
