Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT –KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON B4188 BELBROUGHTON ROAD AND GLADSTONE PLACE, BLAKEDOWN]

Map and plan of the area

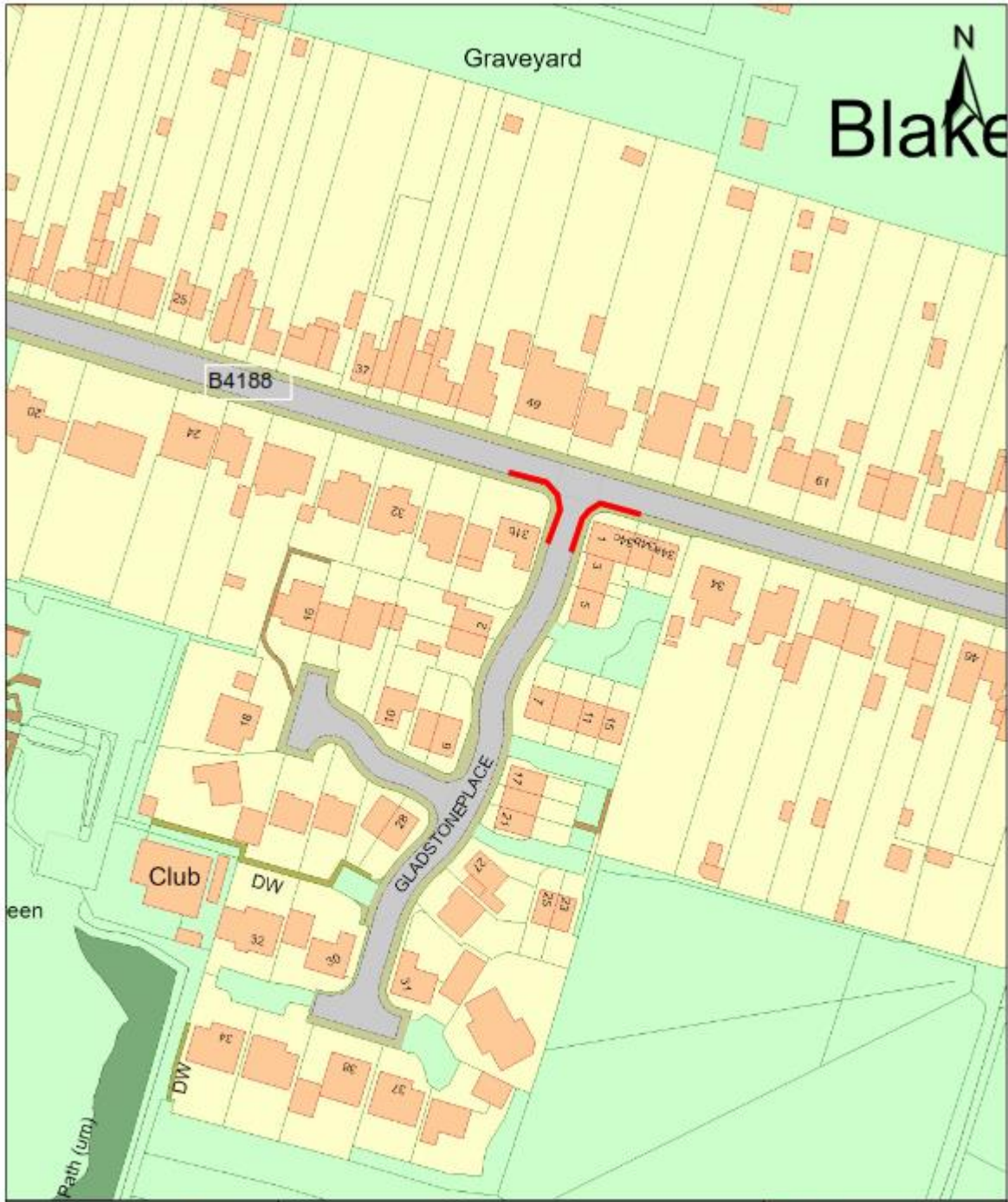
Map of B4188 Belbroughton Road and Gladstone Place, Blakedown and the prohibition of waiting zone implemented by the above order.

Description of the map

The map shows the prohibition of waiting zone on **B4188 Belbroughton Road and Gladstone Place, Blakedown**:-

B4188 Belbroughton Road (South side): from its junction with Gladstone Place for a distance of 10 metres in an easterly direction and 8 metres in a westerly direction.

Gladstone Place (Both sides): from its junction with B4188 Belbroughton Road for a distance of 12 metres in a southerly direction.
