- 3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 4. This Order may be cited as Worcestershire County Council The County of Worcestershire (C2109 and C2209 Station Road, Wadborough) (Restricted Roads) Order 2000 (Revocation) and (Various Roads, Wadborough) (30 mph Speed Limit) Order 2024 and shall come into operation on 25 July 2024.

The map shows the extended 30 miles per hour speed limit on Various Roads, **Wadborough:** 

**C2100**, **Wadborough**: From its junction with C2109 for a distance of 156 metres in a southerly direction and for a distance of 410 metres in a north westerly direction.

**C2109, Wadborough:** From a point 18 metres west of its junction with C2100 for a distance of 160 metres in a north easterly direction.

**C2209 (Station Road):** From its junction with the C2109 for a distance of 282 metres in a north westerly direction.
