## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### Description of the map

The map shows the prohibition of waiting zones on Marlpool Lane (St Catherine's Primary School), **Kidderminster**:

**Marlpool Lane (east side)** from its junction with Willowfield drive for a distance of 15m in a southerly direction.

**Marlpool Lane (west side)** from its junction with Willowfield drive for a distance of 17m in a southerly direction and 13m in a northern westerly direction.
