Description of the map

The map shows the prohibition of waiting zones on Bradley Drive, Malvern:

Leigh Sinton Road (west side) from its junction with Bradley Drive for a distance of 17m in a northerly direction and 15M in a southerly direction.

Bradley Drive (north side) from its junction with Leigh Sinton Road for a distance of 23m in a westerly direction

Bradley Drive (south side) from its junction with Leigh Sinton Road for a distance of 23m in a westerly direction.
