## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON BROAD STREET/DUKE STREET, KIDDERMINSTER]**

Map of Broad Street, Duke Street, Kidderminster and the prohibition of waiting zones implemented by the above order.

### Description of the map

The map shows the prohibition of waiting zones on Broad Street, Duke Street, Kidderminster:

**Broad Street (south west side)**- from its junction with Duke Street for a distance of 16m in a southerly direction and 8m in a northerly direction.

**Duke Street (south east side)**- from its junction with Broad Street for a distance of 10m in a western southerly direction.

**Duke Street (north west side)**- from its junction with Broad Street for a distance of 10m in a western southerly direction.
