Map of Broad Street, Duke Street, Kidderminster and the prohibition of waiting zones implemented by the above order.

Description of the map

The map shows the prohibition of waiting zones on Broad Street, Duke Street, **Kidderminster:**

Broad Street (south west side)- from its junction with Duke Street for a distance of 16m in a southerly direction and 8m in a northerly direction.

Duke Street (south east side)- from its junction with Broad Street for a distance of 10m in a western southerly direction.

Duke Street (north west side)- from its junction with Broad Street for a distance of 10m in a western southerly direction.
