## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT –KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON CONNAUGHT AVENUE/ SUTTON PARK ROAD/RESERVOIR ROAD, KIDDERMINSTER]**

### Description of the map

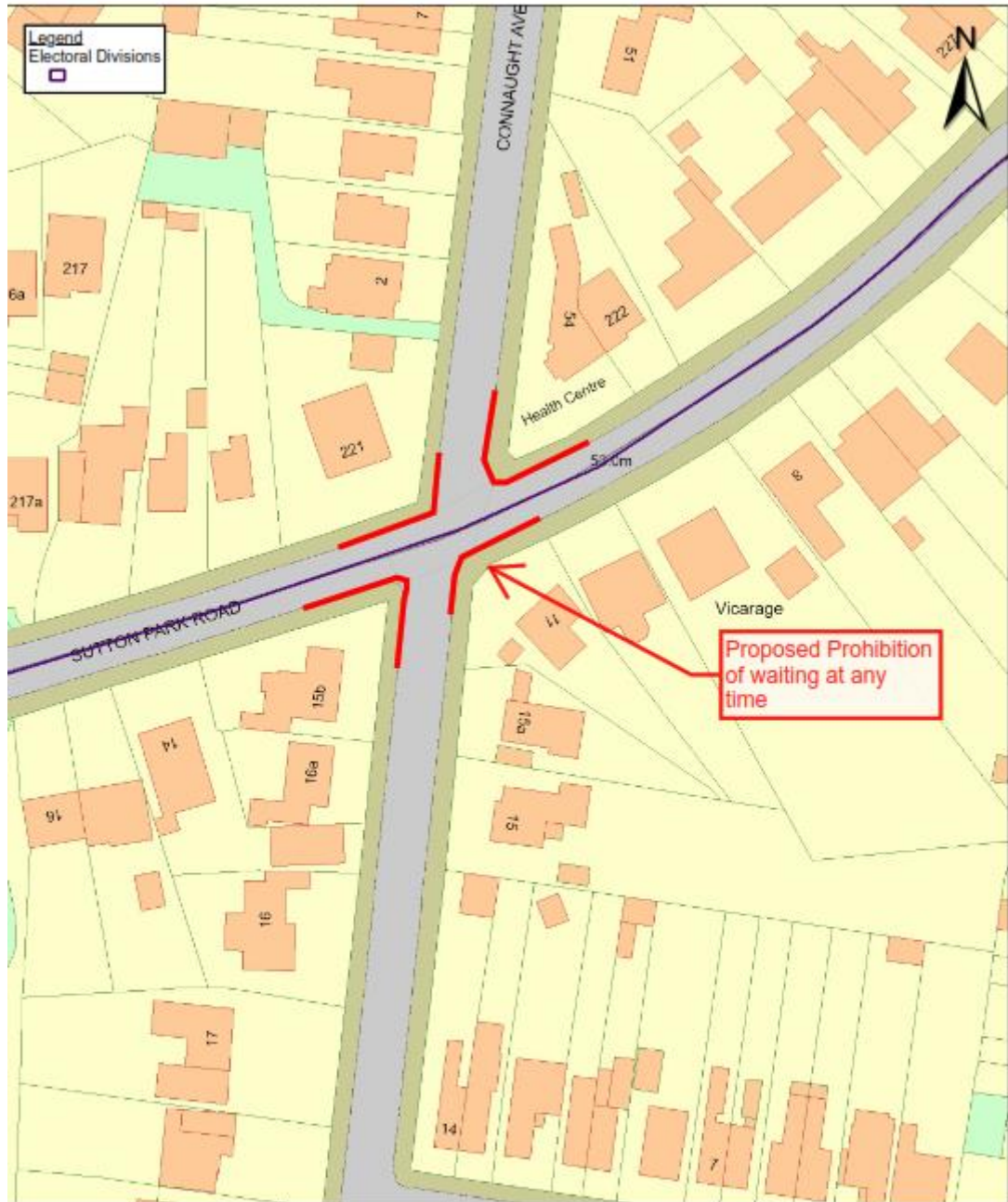
The map shows the prohibition of waiting zone on Connaught Avenue/ Sutton Park Road/ Reservoir Road, **Kidderminster**: -

**Sutton Park road (north side)** from its junction with Connaught Avenue for a distance of 15m easterly direction and 15m in westerly direction.

**Connaught Avenue (both sides) from** its junction with Sutton Park Road for a distance of 10m in a northerly direction.

**Sutton Park Road (south side)** from its junction with Reservoir Road for a distance 15m easterly direction and 15m in westerly direction.

**Reservoir Road (both sides)** from its junction with Sutton Park Road for a distance of 10m in a southerly direction.
