## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT – STOURPORT area) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2007 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON KYLEMILNE WAY, STOURPORT]**

Worcestershire County Council have made this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

### Description of the map

The map shows the prohibition of waiting zone on Kylemilne Way, **Stourport**: -  
**Kylemilne Way (north side)**. From a point 32m east of its junction with Hartlebury road for a distance of 50m in an easterly and then southerly direction, around the bend.

**Kylemilne Way (south side)**. From a point 32m east of its junction with Hartlebury road for a distance of 32m in an easterly and then southerly direction, around the bend.
