Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (DISTRICT OF WYCHAVON – DROITWICH AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2004 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON CELVESTUNE WAY, DROITWICH]

Worcestershire County Council propose to make an Order for facilitating the passage on the roads or any other roads of any class of traffic.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s.122 Road Traffic Regulation Act 1984.

ROAD TRAFFIC REGULATION ACT 1984 WORCESTERSHIRE COUNTY COUNCIL (DISTRICT OF WYCHAVON – DROITWICH AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2004 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON CELVESTUNE WAY, DROITWICH]

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 3 (1), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (District of Wychavon – Droitwich Area) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the lengths and sides of roads identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXXX 2024 and may be cited as Worcestershire County Council (District of Wychavon – Droitwich area) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 (Variation) Order 2024 [Prohibition of Waiting on Celvestune Way, Droitwich]

Description of the map

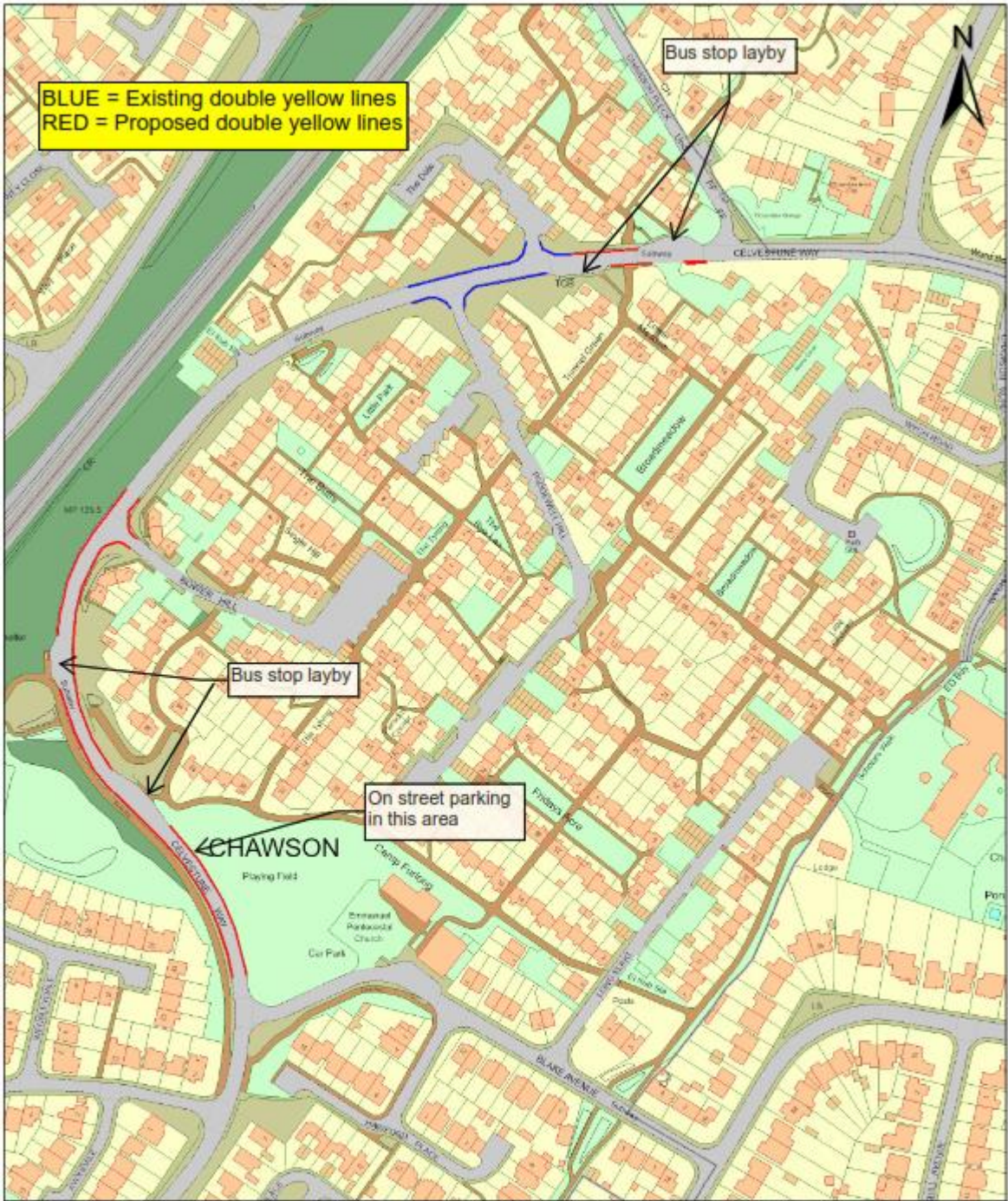
The map shows the proposed prohibition of waiting zones on Celvestune Way, **Droitwich: Celvestune Way, Droitwich (North Side)**: From a point 10 metres east of its junction with The Dale for a distance of 29 metres in an easterly direction.

East side: From a point 5 metres north of its junction with Blake Avenue for a distance of 86 metres in a northerly direction. From its junction with Bower Hill for a distance of 110 metres in a southerly direction and a distance of 10 metres in a northerly direction.

South side: From the garage block access opposite Chawson Pleck for a distance of 19 metres in a westerly direction and a distance of 10 metres in an easterly direction.

West side: From a point 5 metres north of its junction with Blake Avenue for a distance of 166 metres in a northerly direction. From a point 10 metres north of its junction with Bower Hill for a distance of 78 metres in a southerly direction.

Bower Hill, Droitwich (Both sides): From its junction with Celvestune Way for a distance of 10 metres in an easterly direction.
