## ROAD TRAFFIC REGULATION ACT 1984 WORCESTERSHIRE COUNTY COUNCIL (VARIOUS ROADS, FINSTALL) (REVOCATION) AND (30 MPH SPEED LIMIT) ORDER 2024

Worcestershire County Council in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (which said Act is herein after referred to as 'the Act of 1984') and Part IV of Schedule 9 to the Act of 1984 and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 30 miles per hour along those lengths of road as specified in the Schedule to this Order.
2. That Worcestershire County Council The County of Hereford and Worcester (Restricted Roads) (No14) Order 1980 30MPH Speed Limit, Heydon Road, Finstall Village Bromsgrove (Revocation), (Various Roads, Finstall) (Restricted Roads) Order 2002 (Variation) and (Various Roads, Finstall) (30mph Speed Limit) Order 2014 is hereby revoked in its entirety.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
4. This Order may be cited as Worcestershire County Council (Various Roads, Finstall) (Revocation) and (30 mph Speed Limit) Order 2024 and shall come into operation on 5 September 2024.

30 mph Speed Limit on the following lengths of roads in the Finstall, in the District of Bromsgrove, in the County of Worcestershire subject to the provisions of this Order:

<b>B4184 Alcester Road:</b>	From its junction with B4184 Finstall Road and C2247 Alcester Road/Stratford Road for a distance of 480 metres in an easterly direction.
<b>B4184 Finstall Road</b>	From its junction with B4184 Alcester Road and C2247 Alcester Road/Stratford Road in a generally south westerly direction to a point 21 metres south east of the centre line of the railway bridge.
<b>C2247 Alcester Road/Stratford Road</b>	From its junction with U21389 Regents Park Road to its junction with B4184 Alcester Road/Finstall Road.
<b>U22015 Heydon Road</b>	For its entire length.
<b>U22017 Pikes Pool Lane</b>	From its junction with C2247 Alcester Road/Stratford Road for a distance of 25 metres in a northerly direction.
<b>U22018 Penmanor</b>	For its entire length.


#### (VARIOUS ROADS, FINSTALL) (REVOCATION) AND (30 MPH SPEED LIMIT) ORDER 2024

Worcestershire County Council in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (which said Act is herein after referred to as 'the Act of 1984') and Part IV of Schedule 9 to the Act of 1984 and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 30 miles per hour along those lengths of road as specified in the Schedule to this Order.
2. That Worcestershire County Council The County of Hereford and Worcester (Restricted Roads) (No14) Order 1980 30MPH Speed Limit, Heydon Road, Fininstall Village Bromsgrove (Revocation), (Various Roads, Fininstall) (Restricted Roads) Order 2002 (Variation) and (Various Roads, Fininstall) (30mph Speed Limit) Order 2014 is hereby revoked in its entirety.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
4. This Order may be cited as Worcestershire County Council (Various Roads, Fininstall) (Revocation) and (30 mph Speed Limit) Order 2024 and shall come into operation on 5 September 2024.

30 mph Speed Limit on the following lengths of roads in the Finstall, in the District of Bromsgrove, in the County of Worcestershire subject to the provisions of this Order:

<b>B4184 Alcester Road:</b>	From its junction with B4184 Finstall Road and C2247 Alcester Road/Stratford Road for a distance of 480 metres in an easterly direction.
<b>B4184 Finstall Road</b>	From its junction with B4184 Alcester Road and C2247 Alcester Road/Stratford Road in a generally south westerly direction to a point 21 metres south east of the centre line of the railway bridge.
<b>C2247 Alcester Road/Stratford Road</b>	From its junction with U21389 Regents Park Road to its junction with B4184 Alcester Road/Finstall Road.
<b>U22015 Heydon Road</b>	For its entire length.
<b>U22017 Pikes Pool Lane</b>	From its junction with C2247 Alcester Road/Stratford Road for a distance of 25 metres in a northerly direction.
<b>U22018 Penmanor</b>	For its entire length.

### Description of the map

The map shows the 30 miles per hour speed limit zones on various roads, **Finstall:**

**B4184 Alcester Road** from its junction with B4184 Finstall Road and C2247 Alcester Road/Stratford Road for a distance of 480 metres in an easterly direction.

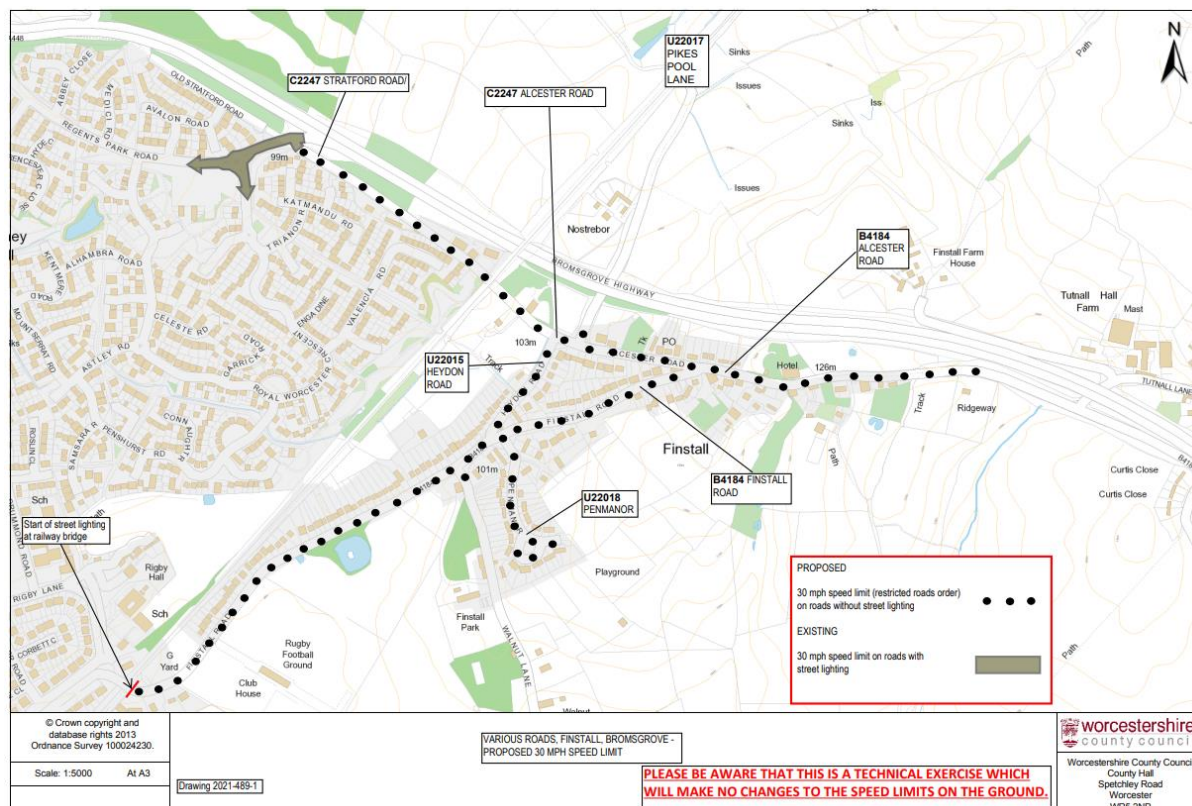
**B4184 Finstall Road** from its junction with B4184 Alcester Road and C2247 Alcester Road/Stratford Road in a generally south westerly direction to a point 21 metres south east of the centre line of the railway bridge.

**C2247 Alcester Road/Stratford Road** from its junction with U21389 Regents Park Road to its junction with B4184 Alcester Road/Finstall Road.

**U22015 Heydon Road** for its entire length.

**U22017 Pikes Pool Lane** from its junction with C2247 Alcester Road/Stratford Road for a distance of 25 metres in a northerly direction.

**U22018 Penmanor** for its entire length.

Worcestershire County Council in exercise of their powers under Part VI of the Road Traffic Regulation Act 1984 (which said Act is herein after referred to as 'the Act of 1984') and Part IV of Schedule 9 to the Act of 1984 and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. That The County of Hereford and Worcester (Restricted Roads) (No14) Order 1980 30 mph Speed Limit, Heydon Road, Fininstall Village, Bromsgrove, is revoked in its entirety.
2. That The Worcestershire County Council Various Roads, Fininstall (Restricted Roads) Order 2002 is hereby varied and shall have the effect as though the item in the Schedule relating to B4184 (Fininstall Road) is revoked in its entirety.
3. That The Worcestershire County Council Various Roads, Fininstall (Restricted Roads) Order 2002 is hereby varied and shall have the effect as though the item in the Schedule relating to A491 (Alcester Road) is revoked in its entirety.
4. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 30 miles per hour along the lengths of road specified in the Schedule to this Order.
5. All other Orders made prior to the date of this Order applying to any of the lengths of roads specified in the Order are hereby revoked or varied as may be required.
6. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
7. This Order may be cited as Worcestershire County Council The County of Hereford and Worcester (Restricted Roads) (No 14) Order 1980 30mph Speed Limit, Heydon Road, Fininstall Village, Bromsgrove (Revocation), Various Roads, Fininstall (Restricted Roads) Order 2002 (Variation) and (Various Roads, Fininstall) (30mph Speed Limit) Order 2014 and shall come into operation on 8 May 2014.
