- 3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 4. This Order may be cited as Worcestershire County Council (Various Roads, Upper Moor) (40 mph Speed Limit) Order 2000 (Revocation) and (Various Roads, Upper Moor) (40 mph Speed Limit) Order 2024 and shall come into operation on 22 August 2024.


The map shows the 40 mph speed limit zones on Various Roads, Upper Moor:
