WORCESTERSHIRE COUNTY COUNCIL (VARIOUS ROADS, UPPER MOOR) (40 MPH SPEED LIMIT) ORDER 2000 (REVOCATION) AND (VARIOUS ROADS, UPPER MOOR) (40 MPH SPEED LIMIT) ORDER 2024

Worcestershire County Council have made this Order for preserving or improving amenities of the area through which the roads runs.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s122 Road Traffic Regulation Act 1984

Worcestershire County Council in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (which said Act is herein after referred to as 'the Act of 1984') and Part IV of Schedule 9 to the Act of 1984 and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. That The Worcestershire County Council (Various Roads, Upper Moor) (40 MPH Speed Limit) Order 2000 is hereby revoked.
2. No person shall drive or cause or permit be driven any motor vehicle at a speed exceeding 40 miles per hour along those roads as specified in Schedule 1 to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
4. This Order may be cited as Worcestershire County Council (Various Roads, Upper Moor) (40 mph Speed Limit) Order 2000 (Revocation) and (Various Roads, Upper Moor) (40 mph Speed Limit) Order 2024 and shall come into operation on 22 August 2024.

4. This Order may be cited as Worcestershire County Council (Various Roads, Upper Moor) (40 mph Speed Limit) Order 2000 (Revocation) and (Various Roads, Upper Moor) (40 mph Speed Limit) Order 2024 and shall come into operation on 22 August 2024.

U47231 Evesham Road – from its junction with A44 for a distance of 595 metres in a westerly direction.

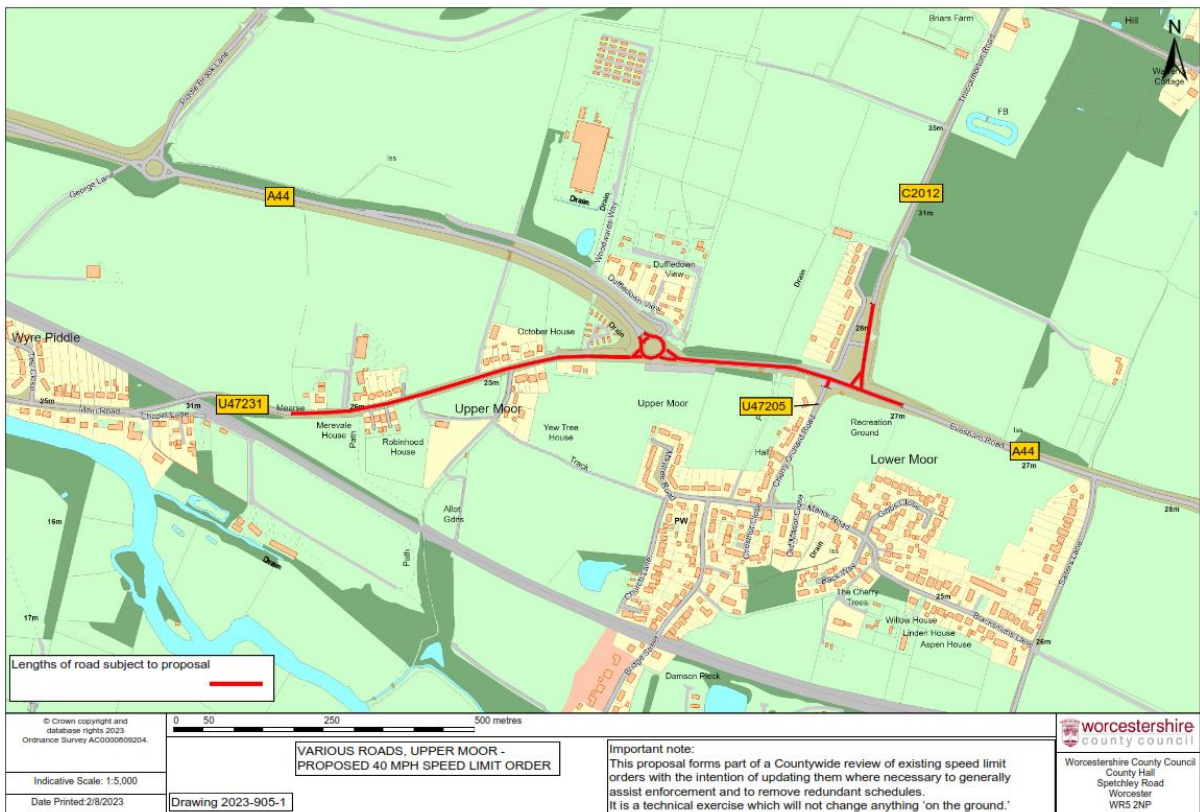

Worcestershire County Council in exercise of their powers under Section 84(3) and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order: -

1. The County of Hereford and Worcester (A4538 Martin Hussingtree to Evesham Road, Upper Moor) (50 M.P.H. Speed Limit) (No. 4) Order 1994 is hereby revoked.
2. No person shall drive or cause or permit be driven any motor vehicle at a speed exceeding 40 miles per hour along those lengths of roads specified in the Schedule to this Order.
3. This Order may be cited as Worcestershire County Council (Various Roads, Upper Moor) (40 M.P.H. Speed Limit) Order 2000 and shall come into operation on 25 July 2000.

C2012	From its junction with A4538 for a distance of 130 metres in a northerly direction.
UC47205 (Cherry Orchard Road)	From its junction with A4538 for a distance of 35 metres in a southerly direction.
