## WORCESTERSHIRE COUNTY COUNCIL (C2118 HIMBLETON) (NO STOPPING ON SCHOOL KEEP CLEAR MARKINGS) ORDER 2024

Worcestershire County Council in exercise of their powers under Sections 1, 2, 3, and 4 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

- 1. Save as provided in Article 2 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to stop at any time on School Keep Clear Markings as specified in the Schedule to this Order
- 2. Nothing in Article 1 of this Order shall apply:-
  - (a) to a vehicle stopping on the school keep clear markings referred to in Article 1 for so long as may be necessary to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road including and comprising of the school keep clear markings, or the laying, erection, alteration or repair in or near such road of any sewer or of any main, pipe or apparatus for the supply of gas, water or sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications defined apparatus as in the Telecommunications Act 1984;
  - (b) to a vehicle being used for fire brigade, ambulance or police purposes;
  - (c) to a vehicle being used in pursuance of statutory powers or duties;
  - (d) to a vehicle stopping on the school keep clear markings referred to in Article 1 for so long as is necessary to enable any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged to be opened or closed if it is not practicable for the vehicle to wait otherwise than on the school keep clear markings.

- (e) to a vehicle stopping on the school keep clear markings referred to in Article 1 when the person in control of the vehicle:-
  - (i) is required by law to stop;
  - (ii) is obliged to do so in order to avoid an accident; or
  - (iii) is prevented from proceeding by circumstances outside his control and it is not reasonably practicable for him to drive or move the vehicle to a place not on the school keep clear markings referred to in Article 1.
- 3. This Order shall come into operation on xxxxx 2024 and may be cited as (C2118 Himbleton) (No Stopping on School Keep Clear Markings) Order 2024.

### **Description of the map**

The map shows the proposed Prohibition of Waiting/Limited Waiting on **C2118 Himbleton:** 

**South side:** From its junction with Blackpit Lane for a distance of 106 metres in a northwesterly direction.

Limited waiting 8am - 4pm, 1 hour, no return within 1 hour & Prohibition of Waiting 4pm – 8am.

**South side:** From a point 10 metres southeast of the intersection of C2032 & C2118 for a distance of 63 metres in a southeasterly direction.

The proposed **No Stopping on School Keep Clear Markings** on **C2118 Himbleton:** (South side): From a point 73 metres southeast of the intersection of C2032 & C2118 for a distance of 22 metres in a southeasterly direction.
