Worcestershire County Council in exercise of their powers under Section 1 (1), 2 (1) to (3) of the Road Traffic Regulation Act 1984 and of all other powers them enabling in that behalf, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. No person shall, except upon the direction or with the permission of a police officer in uniform, or a traffic warden, cause or permit any vehicle to proceed along Redditch Police and Fire Station Egress for its entire length. Vehicles may only proceed in a west to east direction.
2. Nothing in Article 1 of this Order shall apply to any mechanical road cleansing vehicle;
3. This Order shall come into operation on 3 October 2024 and may be cited as Worcestershire County Council (Redditch Police and Fire Station Egress, Redditch) (One-Way Traffic) Order 2024.
