7. A "key decision" is one which:
 - Is in connection with the discharge of an executive function and
 - involves significant expenditure or savings having regard to the budget for the related service or function; or
 - has a significant effect on communities in two or more electoral divisions.
8. An 'executive function' is one which is the responsibility of the Leader and Cabinet.
9. An 'executive decision-making body' includes the Cabinet or a committee of it, or a joint committee of the executives of 2 or more authorities.

11. Notice of key decisions to be taken by individual Cabinet Members with Responsibility will also be included.

Healthy Children and Young People – Recommissioning Public Health Services

Key Decision	<p>This key decision relates to the recommissioning of 0-19 age Public Health services across Worcestershire (the Prevention and Early Intervention Service for children and young people). This includes Public Health nursing and Parenting and Community support (through Family Hubs).</p> <p>Commissioning Public Health services for children is a duty of the Council under the Childcare Act, 2006 and Health and Social Care Act, 2012.</p> <p>It is proposed to move from the Lead Provider model (whereby NHS Herefordshire and Worcestershire Health and Care Trust deliver the Public Health Nursing element and subcontract the Parenting and Community services to Redditch Council, Barnardo’s and Action for Children) to WCC contracting directly and separately with the four providers.</p> <p>Whilst the proposed recommissioning of this contract will not render the services materially different; the revised service delivery model (separating Public Health nursing and the community provision) will better meet the rising and complex needs of local families and changing Government policy and ensure more transparent and cost-effective delivery.</p>
