

NOTICE OF CONFIRMATION OF AN ORDER

HIGHWAYS ACT 1980
WILDLIFE AND COUNTRYSIDE ACT 1981

WORCESTERSHIRE COUNTY COUNCIL

DIVERSION OF FOOTPATHS SY-573, SY-574 AND SY-575, (FORMERLY FOOTPATH 21) IN THE PARISH OF SHRAWLEY

On 7th March 2024, Worcestershire County Council confirmed the above order made under Section 119 of the Highways Act 1980, and Section 53A(2) of the Wildlife and Countryside Act 1981.

The effect of the order as confirmed is to divert paths:

SY-573 running from OSGR SO 7953 6423 (point A on the order map). the footpath proceeds in an east-north-easterly direction, along a private driveway, for 97 metres to terminate at its junction with footpath SY-574 and SY-575 at OSGR SO 7962 6426 (point B on the order map), to a line running from OSGR SO 7954 6418 (point H on the order map); the path proceeds in an east south-easterly direction, through a gate at OSGR SO 7954 6417 (point G on the order map) and passing through a wooded copse for 15 metres, then turns in an east by northerly direction for 84 metres across a field to a gate at OSGR SO 7966 6425 (point E on the order map)), as shown on the order map.

SY-574 running from OSGR SO 7962 6426 (point B on the order map). The path proceeds in a north-easterly direction across a paddock for 69 metres to OSGR SO 7967 6431 (Point C on the Order map), then turns in a north-north-easterly direction for 67 metres, through a gate, to terminate at OSGR SO 7969 6437 (point D on the order map), to a line running from OSGR SO 7966 6425 (point E on the order map). the path proceeds in a north north-easterly direction for 119 metres, along the field edge, then turns west north-westerly for 12 metres to terminate at its junction with the existing footpath SY-574 at OSGR SO 7696 6437 (point D on the order map), as shown on the order map.

SY-575 running from OSGR SO 7962 6426 (point B on the order map) the path proceeds in an easterly direction across a paddock of 40 metres to OSGR SO 7966 6426 (point E on the order map), to a line running commencing at a gate at OSGR SO 7964 6418 (point F on the order map). the path then continues in a north easterly direction for 74 metres, along the field edge, to its junction with footpath SY-574 at OSGR SO 7966 6426 (point E on the order map), as shown on the order map.

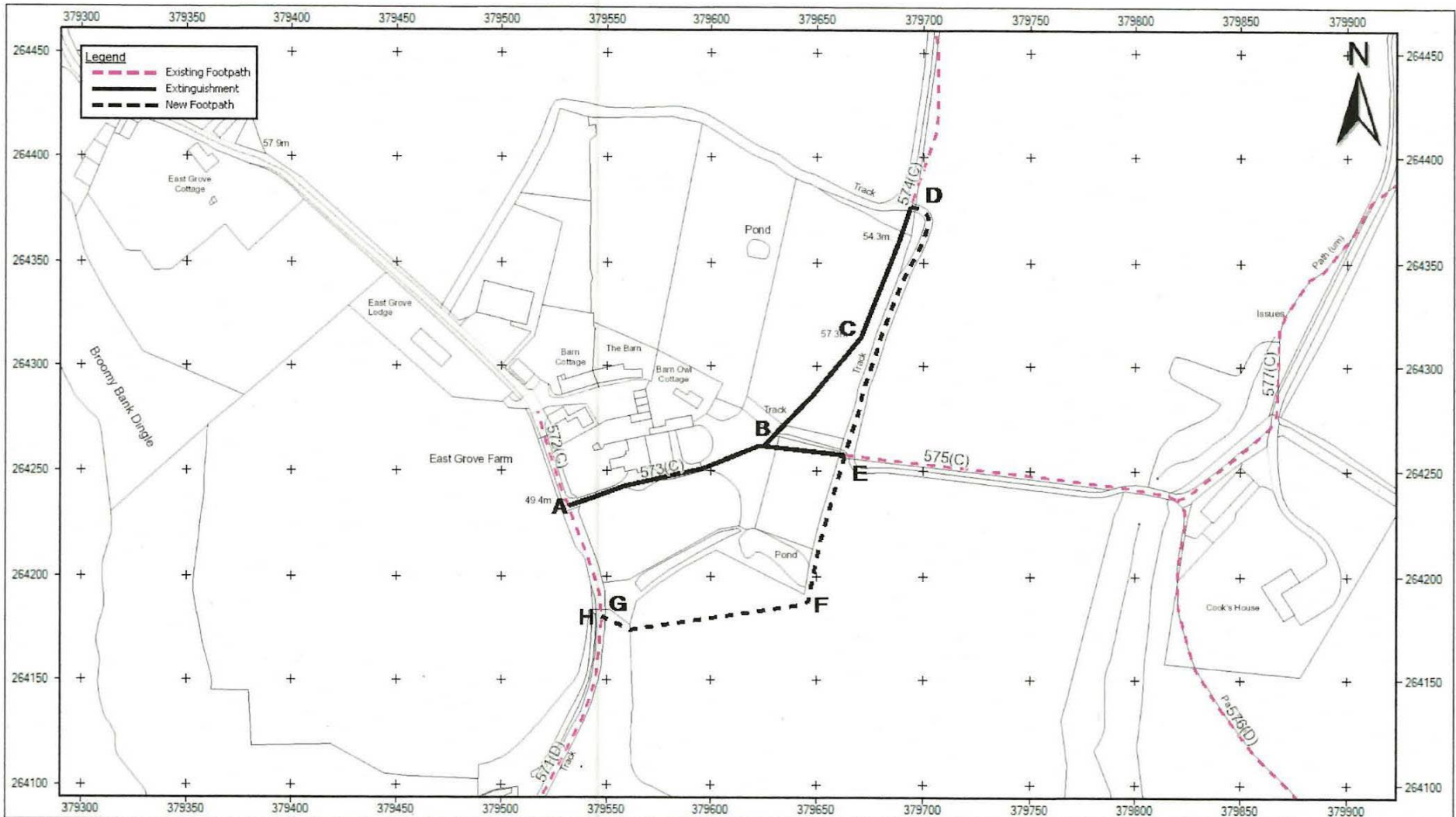

The order comes into force as of 7th march 2024 but if any person aggrieved by the order wants to question its validity or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act, has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from the date of the notice, make an application to the High Court.

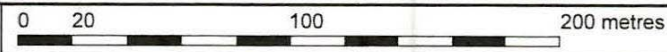
