## Introduction and purpose of document

This document was created by WCC EP Team and Associate EPs who complete statutory assessments on behalf of WCC EP Team, following feedback from 9 families (out of 70) in our questionnaire data who felt that EPs could only 'partially' answer all of their questions. An invitation to Families in Partnership and the WCC Parent Engagement Advisor to contribute was also made. This is an initial draft and will be revised over time in response to any feedback given.

The purpose of this document is to reflect the questions and answers that parent/carers may have by way of signposting EPs and parent/carers to the information they need.

The document is organised based on themes of questions, and there are links to the local offer and other websites in the appendix.

## Timescales

### How long will it take from your report to when I hear from SEND with a draft EHC Plan if they agree to a Plan?

There is a 20 week statutory timeframe from request submission to final plan; so based on the dates this would be approximately.....*(and the EP will work with parent/carer to establish what this is).*

### What happens now?

SEND Services will review all of the reports from professionals to decide if an Education, Health and Care Plan is required for your son/daughter. SEND Services will send you a copy of the psychological advice/report.

## Outcomes of assessment

### Does this mean they will get an EHC Plan?

EPs can't give an answer because we are advice givers and not decision makers. We do not see all of the reports provided for the statutory assessment, as our report, and those of others, gets sent to SEND Services. SEND Services make the decision following the assessment about whether to issue an education, health and care plan.

## Transport to school/setting

### Can you support my request for LA transport for my child?

The decision making around LA transport is not something that EPs are involved in however, we will record parents/carers needs/request for this support within our psychological advices so that SEND Services know that parents have discussed this with us.

## Accessing health assessments, for example ASD or ADHD

### How do I get my son/daughter assessed for ASD/ADHD? And how long does it take?

EPs are not involved in these specific assessments. Parent/carers need to seek medical advice about this and can also talk to the SENCO at school. The SENCO might also make contact with the

Worcestershire County Council Complex Communication Needs Team who can provide advice and support in school.

### Does my son/daughter need a diagnosis of ASD/ADHD to get an Education, Health and Care plan?

No; the statutory assessment process looks at what the needs of your child are, rather than what diagnoses they may have been given.

### How will my son/daughter's demand avoidant behaviours be reflected in the psychology advice?

As with all needs, this will be explained in relation to the triangulation of evidence as a result of the assessment, and how this impacts on your son/daughter's access to their education.
