## **WORCESTERSHIRE COUNTY COUNCIL (BOROUGH OF REDDITCH) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2009 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON STONEPIT LANE, CHESTERTON CLOSE JUNCTION, REDDITCH**

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXX 2024 and may be cited as Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 (Variation) Order 2024 [Prohibition of Waiting on Stonepit Lane, Chesterton Close Junction, Redditch].

## Description of the map

The map shows the proposed prohibition of waiting zone to be implemented on Stonepit Lane, Chesterton Close Junction, **Redditch**:  
**Stonepit Lane (West Side)** from a point 12 metres southwest of its junction with Brookfield close for a distance of 45 metres in a south westerly direction.
