

Map and plan of the area

Map of Andrew Close, Worcester and the prohibition of waiting, restriction of waiting and limited waiting zones implemented by the above order.

Description of the map

The map shows the prohibition of waiting, restriction of waiting and limited waiting zones on Andrew Close, **Worcester**:

Andrew Close: (North side) from a point 11 metres east of its junction with Comer Gardens for 12 metres in an easterly direction.

Restrict Waiting Order (No Waiting Monday to Friday 10am to 4pm)

(North side) From a point 23 metres east of its junction with Comer Gardens for 77 metres in an easterly direction.

(South side) From a point 21 metres east of its junction with Comer Gardens for 20 metres in an easterly direction.

From a point 46 metres east of its junction with Comer Gardens for 10 metres in an easterly direction.

From a point 63 metres east of its junction with Comer Gardens for 10 metres in an easterly direction.

From a point 78 metres east of its junction with Comer Gardens for 15 metres in an easterly direction.

Limited Waiting (Maximum stay 2 hours no return within 2 hours Monday to Friday 10am to 4pm)

(South side) From a point 11 metres east of its junction with Comer Gardens for 10 metres in an easterly direction.

From a point 41 metres east of its junction with Comer Gardens for 5 metres in an easterly direction

From a point 56 metres east of its junction with Comer Gardens for 7 metres in an easterly direction.

From a point 78 metres east of its junction with Comer Gardens for 5 metres in an easterly direction.
