## Map and plan of the area

Map of Celvestune Way, Droitwich and the prohibition of waiting zone implemented by the above order.

## **Description of the map**

The map shows the prohibition of waiting zone on Celvestune Way, **Droitwich: Celvestune Way, Droitwich (North Side):** From a point 10 metres east of its junction with The Dale for a distance of 29 metres in an easterly direction.

**East side:** From a point 5 metres north of its junction with Blake Avenue for a distance of 86 metres in a northerly direction. From its junction with Bower Hill for a distance of 110 metres in a southerly direction and a distance of 10 metres in a northerly direction. **South side:** From the garage block access opposite Chawson Pleck for a distance of 19 metres in a westerly direction and a distance of 10 metres in an easterly direction. **West side:** From a point 5 metres north of its junction with Blake Avenue for a distance of 166 metres in a northerly direction. From a point 10 metres north of its junction with Blake Avenue for a distance of 166 metres in a northerly direction. From a point 10 metres north of its junction with Bower Hill for a distance of 78 metres in a southerly direction.

**Bower Hill, Droitwich (Both sides):** From its junction with Celvestune Way for a distance of 10 metres in an easterly direction.
