Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (BROMSGROVE DISTRICT) (CIVIL ENFORCEMENT AREA (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2013 (VARIATION) ORDER 2024 [EXPERIMENTAL PROHIBITION OF WAITING ON EACHWAY AND HOLMES DRIVE, REDNAL]

Worcestershire County Council have made this Order for facilitating the safe passage on the roads or any other roads of any class of traffic and for avoiding danger to persons or other traffic using the roads or any other roads or for preventing the likelihood of any such danger arising.

The Order shall come into operation on 5 December 2024 and may be cited as Worcestershire County Council (Bromsgrove District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2024 [Experimental Prohibition of Waiting on Eachway and Holmes Drive, Rednal].

Map of Eachway and Holmes Drive, Rednal and the proposed experimental prohibition of waiting zones to be implemented by the above order.

Description of the map

The map shows the proposed experimental prohibition of waiting zones on Eachway and Holmes Drive, **Rednal**:

Holmes Drive: (North side) from a point of its junction with Eachway for a distance of 10 metres in a westerly direction.

(South side) from a point of its junction with Eachway for a distance of 10 metres in westerly direction.
