- 1. The Worcestershire County Council (City of Worcester) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2011 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order a prohibition of waiting at any time, restriction of waiting Monday Friday 8.30am-5pm and revocation of restriction of waiting Monday Friday 8.30am-5pm in accordance with the provisions of the Consolidation Order).
- The Order shall come into operation on XXXX 2024 and may be cited as Worcestershire County Council (City of Worcester) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2011 (Variation) Order 2024 [Various Waiting Restrictions (Proposals and Revocation) on Laugherne Road and Comer Road Worcester]

Map of Laugherne Road and Comer Road, Worcester and the proposed various waiting restriction zones to be implemented by the above order.

Description of the map

The map shows the proposed various waiting restriction zones on Laugherne Road and Comer Road, **Worcester:**

Laugherne Road (west side) from its junction with Rowley Hill Street for a distance of 6 metres in a northerly direction.

Laugherne Road (west side) from a point 6 metres south of its junction with Rowley Hill Street for a distance of 6 metres in a southerly direction.

Restriction of Waiting MON-FRI 8.30am-5pm

Laugherne Road (west side) from a point 10 metres north of its junction with Buck Street to a point 10 metres south of its junction with Windsor Avenue.

Laugherne Road (east side) from a point 13 metres north of the centre line of its junction with Windsor Avenue for a distance of 7 metres in a northerly direction.

Revocation of Restriction of Waiting Mon-Fri 8.30am-5pm

Comer Road (east side): from a point 30 metres north of its junction with Nelson Road for a distance of 21 metres in a northerly direction.
