Map of Bromwich Road and Whites Road, Worcester and the proposed to be prohibition of waiting zone implemented by the above order.


Description of the map

The map shows the proposed prohibition of waiting zone on Bromwich Road and Whites Road, **Worcester**

Bromwich Road (West side): from its junction with Whites Road for a distance of 33 metres in a northerly direction and 27 metres in a south westerly direction; and from a point 15 metres southwest of its junction with Bromwich Road Service Road (north junction) for a distance of 14 metres in a south westerly direction.

Whites Road (North side): from its junction with Bromwich Road for a distance of 32 metres in a westerly direction;

(South side): from its junction with Bromwich Road for a distance of 25 metres in a westerly direction.
