Description of the map

The map shows the experimental prohibition of waiting zone on **The Hedgerows, Romsley:-St Kenelms Road: (Northeast side)** from its junction with The Hedgerows for a distance of 3 metres in a north easterly direction. (**Southwest side)** from its junction with the Hedgerows for a distance of 3 metres in a westerly direction.

The Hedgerows: (Southeast side) from its junction with St Kenelms Road for a distance of 10 metres in a southerly direction. **(Southwest side)** from its junction with St Kenelms Road for a distance of 8 meters in a southerly direction.
