The Worcestershire County Council (City of Worcester) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2011 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order a prohibition of waiting at any time and revoking restriction of waiting Monday Saturday 8am-6.30pm and limited waiting 45 mins no return within 2 hours Mon-Sat 8am-6.30pm except permit holders in accordance with the provisions of the Consolidation Order).
- 2. The Order shall come into operation on XXXX 2024 and may be cited as Worcestershire County Council (City of Worcester) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2011 (Variation) Order 2024 [Various Waiting Restrictions (Proposals and Revocations) on Barbourne Terrace, Worcester].

The map shows the proposed Various Waiting Restrictions on Barbourne Terrace, **Worcester:**

Barbourne Terrace (South East side): From its junction with A38 Tything/Barbourne Road for a distance of 103 metres in a south westerly direction.

Revocation of Restriction of Waiting Mon-Sat 8am-6.30pm

From its junction with A38 Tything/Barbourne Road for a distance of 98 metres in a south westerly direction.

Revocation of Limited Waiting 45 mins No Return Within 2 Hours Mon-Sat 8am-6.30pm Except Permit Holders

From a point 98 metres south west of its junction with A38 Tything/Barbourne Road for a distance of 5 metres in a south westerly direction.
