Worcestershire County Council propose to make this Order for facilitating the safe passage on the roads or any other road of any class of traffic and for avoiding danger to persons or other traffic using the roads or any other road or for preventing the likelihood of any such danger arising.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s.122 Road Traffic Regulation Act 1984.

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXX 2024 and may be cited as Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 (Variation) Order 2024 [Prohibition of Waiting on St Georges Road and Grange Road, Redditch].

Map of St Georges Road and Grange Road, Redditch and the proposed prohibition of waiting zone to be implemented by the above order.

Description of the map

The map shows the proposed prohibition of waiting zone on St Georges Road and Grange Road, Redditch:

St Georges Road (Southeast side): from its junction with Grange Road for a distance of 4 metres in a north easterly direction and 8.6 metres in a south westerly direction.

Grange Road (Northeast side): from its junction with St Georges Road for a distance of 5 metres in a south easterly direction.

(Southwest side): from its junction with St Georges Road for a distance of 11 metres in a south easterly direction.
