Description of the map

The map shows the proposed prohibition of waiting zone on Westwood Road, Farmers Way & Paddock Way, **Droitwich:**

Westwood Road (East side): From a point 10 metres south of its junction with Farmers Way for 230 metres in a northerly direction.

(West side): From a point 10 metres south of its junction with Farmers Way for 235 metres in a northerly direction.

Farmers Way (Both sides): From its junction with Westwood Road for 10 metres in an easterly direction.

Paddock Way (Both sides): From its junction with Westwood Road for 10 metres in a westerly direction.
