## Description of the map

The map shows the proposed prohibition of waiting on Friars Mead Lane, **Evesham**:  
**Friars Mead Lane - Evesham – (West Side)** From its junction with Pershore Road for a distance of 38 meters in a northerly direction.  
**Friars Mead Lane - Evesham – (East Side)** From its junction with Pershore Road for a distance of 9 metres in a northerly direction.
