First Meeting with N.R.S Representative

Robin Smythman, some 3 years ago, he
came to our home to discuss how
quarry would affect us. Soon went
down hill fast, told us at our age we
should retire (late 60s), then when

I said. regards of enormous bunds in
front of our bungalow, some 4 Metres. We
would prefer no bunds and look at
quarry. We would not be able to see
anything, to which Mr Smythman replied,
You will if you look up, you will see
the sky. At this, we asked him to
leave, and refused to speak to him
again.

At N.R.S first consultation, did speak
to another man, who told us he was
Director for N.R.S. I told him of our
concerns with bunds, and conveyor
under driveway to our property.

And we have unpaved access, over
driveway, which is also Bridleway.
and would not give our consent to
divert us, while they install tunnel
under driveway.

Whilst discussing the conveyor, I told
him. in my opinion, you may not
be able to get horses over conveyor,

under ground with noise, vibrations, limited sight, for horses can't see each side

At next 2 consultations, had same conversation with this gentleman, about access and conveyor under bridleway. He said, he would look into it and report back to us, but never did.

On 4th consultation, on arrival, same gentleman, asked to speak to us in private, and took us to side room. We asked him who he worked for, as we had been told he is not NRS director. He said, he worked for planning, and their legal team had looked into our rights, concerning driveway, and we could not have any say, on what happens on driveway, so they can do what they want, but then stated we should be cautious, how we proceed, as there had been complaints about condition of driveway which could mean Highways may spend lots of money on it, which we would have to pay 50%, as per our deeds.

We told him, we know our deeds and any money spent on driveway is hard earned Mr Strong, not Highways and left.

If they treat us and locals, now in this manner, what does future hold, if quarry went ahead.

Having since looked at NRS documents, regarding conveyor under bridleway, they recommend, dismantling, to walk horses over mound and conveyor.

This is, as any horse rider knows,

is the most dangerous. Better to stay on board, more control, but also points out there is a problem with conveyor and horses crossing

Whilst my wife Marilyn has long term illness, some 48 years, and no immunity, due to medication, living in countryside helps. But if quarry went ahead, this would close us, as no one would want to keep horses in middle of quarry, and probably unbearable for us to live in middle of a quarry
