Description of the map

The map shows the proposed prohibition of waiting zone on Lickhill Road and Private Access Road, **Stourport**:

Lickhill Road (Northeast side) from the centre point of its junction with the private access road for a distance of 15.5 metres in a north westerly direction.

(Southwest side): from its junction with the private access road for a distance of 14.1 metres in a north westerly direction.

Private access road (Both sides) from its junction with Lickhill Road for a distance of 12.8 metres in a southerly direction.
