Description of the map

The map shows the proposed prohibition of waiting zone on Vicarage Crescent & Bromsgrove Road, **Redditch**:

<u>Vicarage Crescent (Eastern Side)</u>: from its junction with Bromsgrove Road for a distance of 10 metres in a southerly direction;

(Western side): from its junction with Bromsgrove Road for a distance of 10 metres in a southerly direction.

<u>Bromsgrove Road (</u>Southeast side): from its junction with Vicarage Crescent for a distance of 10 metres in an easterly direction:

(Southwest side): from its junction with Vicarage Crescent for a distance of 10 metres in a westerly direction.
