## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **WORCESTERSHIRE COUNTY COUNCIL (BOROUGH OF REDDITCH) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2009 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON VICARAGE CRESCENT & BROMSGROVE ROAD, REDDITCH]**

Worcestershire County Council propose to make this Order for facilitating the safe passage on the road or any other road of any class of traffic and for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

## **WORCESTERSHIRE COUNTY COUNCIL (BOROUGH OF REDDITCH) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2009 (VARIATION) ORDER 2024 [PROHIBITION OF WAITING ON VICARAGE CRESCENT & BROMSGROVE ROAD, REDDITCH]**

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXX 2024 and may be cited as Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 (Variation) Order 2024 [Prohibition of Waiting on Vicarage Crescent & Bromsgrove Road, Redditch].

## Map and plan of the area

Map of Vicarage Crescent & Bromsgrove Road, Redditch and the proposed prohibition of waiting zone to be implemented by the above order.

### Description of the map

The map shows the proposed prohibition of waiting zone on Vicarage Crescent & Bromsgrove Road, Redditch:

**Vicarage Crescent (Eastern Side):** from its junction with Bromsgrove Road for a distance of 10 metres in a southerly direction;

**(Western side):** from its junction with Bromsgrove Road for a distance of 10 metres in a southerly direction.

**Bromsgrove Road (Southeast side):** from its junction with Vicarage Crescent for a distance of 10 metres in an easterly direction;

**(Southwest side):** from its junction with Vicarage Crescent for a distance of 10 metres in a westerly direction.
