The Worcestershire County Council (City of Worcester) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2011 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the road and sides of road identified in the plan attached to this Order a prohibition of waiting and restriction of waiting Mon-Fri 8.30am-5.30pm in accordance with the provisions of the Consolidation Order).
- The Order shall come into operation on XXXX 2024 and may be cited as Worcestershire County Council (City of Worcester) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2011 (Variation) Order 2024 [Prohibition of Waiting and Restriction of Waiting on Williamson Road, Worcester].

#### **Description of the map**

The map shows the proposed prohibition of waiting zone on Williamson Road, **Worcester: Williamson Road (West side):** from a point 63 metres south of its junction with Newtown Road for a distance of 17 metres in a south-westerly direction.

**Williamson Road (West side):** from a point 131 metres south of its junction with Newtown Road for a distance of 76 metres in a southerly direction.

**Williamson Road (East side):** from a point 18 metres south of its junction with Newtown Road for a distance of 184 metres in a southerly direction.

**Williamson Road (East side):** from a point 245 metres south of its junction with Newtown Road for a distance of 50 metres in a southerly direction.

**Williamson Road (East side):** from a point 373 metres south of its junction with Newtown Road for a distance of 50 metres in a southerly direction.

Restriction of Waiting Monday to Friday 8 am-5.30 pm

**Williamson Road (West side):** from a point 80 metres south of its junction with Newtown Road for a distance of 51 metres in a south-westerly direction.

**Williamson Road (West side):** from a point 334 metres south of its junction with Newtown Road for a distance of 78 metres in a southerly direction.
