Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order a prohibition of waiting in accordance with the provisions of the Consolidation Order).
2. The Order shall come into operation on XXXX 2024 and may be cited as Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 (Variation) Order 2024 [Prohibition of Waiting on Wychwood Drive and Walkwood Road, Redditch].

Map of Wychwood Drive and Walkwood Road, Redditch and the proposed prohibition of waiting zones to be implemented by the above order

Description of the map

The map shows the proposed prohibition of waiting zones on Wychwood Drive and Walkwood Road, **Redditch**:

Walkwood Road (Northeast side): from its junction with Wychwood Drive for a distance of 5 metres in an easterly direction.

(Northwest Side): from its junction with Wychwood Drive for a distance of 5 metres in a westerly direction.

Wychwood Drive (Eastern Side): From its junction with Walkwood Road for a distance of 15 metres in a northerly direction.

(Western Side): From its junction with Walkwood Road for a distance of 14 metres in a northerly direction.
