Holiday Activities and Food (HAF) Programme - Winter 2024

A reminder that bookings are now open for Worcestershire's winter Holiday Activities and Food (HAF) Programme!

During the school holidays, eligible families can book FREE holiday activities, family passes and events through the programme.

Funded by the Department for Education, HAF is primarily for children in receipt of benefits related Free School Meals aged 5-16, however, the programme does support other children and young people otherwise considered vulnerable (including LAC, SEND and refugee status).

We would be grateful if you could help us to promote this programme. Families can search and book activities through the HAF booking site. Information and booking instructions to share with families are included in the <u>HAF Winter 2024 School Comms Toolkit</u>. The information is in different formats so can be tailored to the communication channels you use in school.

School holidays can be a difficult time for families, we want to make sure the HAF Programme reaches as many of those who need it as possible. Please support the HAF Programme in your school by:

- Sharing the information linked with eligible families.
- Encouraging families to book activities (HAF activities are FREE to families, no hidden cost (fully funded by the Department for Education).
- Encouraging new starters to sign up to HAF as they sign up to Free School Meals.

They have a suite of online HLTA preparation courses available in the spring term. All courses are delivered online, with the option of AM / PM or Twilight cohorts. Leading to a half day (3 hour) remote assessment. The total cost per candidate is £780.

What we're doing to improve SEND services: December update

The local area partnership is working through the Priority Action Plan and SEND Improvement Plan following the outcome of the 2024 Ofsted and CQC inspection. During November we have been working on:

- Coproduction workshop on 13th November we held a follow up workshop with parent carers on the quality and timeliness of EHCPs. Parent carers made suggestions on how to make improvements through better communication and transparency; and explored how an online system could help to track the EHCP process.
- Children and Young People's Coproduction Lead we are now finalising the job description and person specification for the new role of Children and Young People's Coproduction Lead, to be advertised in January. This role will be crucial in enabling us to better involve children and young people with SEND in making changes and improvements to SEND services.
- Independent Chair recruitment we have completed the interviews for an Independent Chair for the SEND and Alternative Provision Executive Board. An offer has been made and we are now carrying out the standard HR checks and processes before agreeing a start date which will be in the New Year.
- EHCP feedback report part of our quality assurance process includes collecting feedback from
 parent carers following the EHC Needs Assessment process where a new EHCP has been issued
 or following the annual review of an existing plan. The 'you said, we did' style report is available
 on the <u>Local Offer website</u>.

Lumi Nova success and feedback

Thank you to all schools who have signposted parents to <u>Lumi Nova</u>. Take up has been a huge success considering it was only launched in October. <u>Download Lumi Nova Resource Kit</u>

Lumi Nova is an early intervention App for parents and children aged 7-12 to use to address children's common worries, anxieties and fears. Class teachers can signpost parents to the App who can access it for free.

To date over 300 families have accessed Lumi Nova, most of these have been signposted by schools. Of those who have accessed Lumi Nova:

- 42% were male
- 3% were from ethnic minority backgrounds
- 18% reported having a disability

Children select up to 3 worries or anxieties to work through with the App and their parents. The top three concerns selected by children have been:

- Be ok with making a mistake on schoolwork 20%
- Feel comfortable going to school 12%
- Be able to sleep on their own 10%

Managing School Attendance - Supporting Senior Leaders and Attendance Leads

This course is designed to support attendance leaders to embed the requirements of the DfE 'Working together to Improve School Attendance' practices and drive the requirement of attendance becoming everyone's business as part of school culture.

- Consider DfE guidance expectations and the requirements upon attendance managers.
- Explore how Ofsted consider attendance.
- Explore how data can be strategically used to assist attendance management.
- Explore self-assessment and measuring Impact.

- Explore good practice models of addressing persistent and severe absence.
- Enable delegates to explore the important links between attendance and safeguarding.

Worcestershire Youth Cabinet launches new manifesto

Worcestershire Youth Cabinet marked UK Parliament Week by launching their new manifesto, at an event at the Hive on Saturday 23 November.

The counties Youth Cabinet manifesto was developed directly from what young people in Worcestershire voted on as part of the Make Your Mark campaign. Top issues included improving mental health support and hospital experiences for young people, as well as tackling knife crime.

This year, the Cabinet has expanded not only in size, but also in its desire to achieve much more. They have undertaken a range of projects that address critical issues on the minds of young people today - issues such as health and wellbeing, crime and safety, and education. Their focus remains on addressing the concerns raised by young people across the whole of Worcestershire, as highlighted by 'Make Your Mark' programme. It is of vital importance that they continue to tackle the recurrent desire to improve mental health support and hospital experiences as well as knife crime.

Looking ahead, they are keen to see how they can make tangible changes by collaborating closely with key stakeholders, including MPs and councillors, with whom they have already started productive conversations. Their ambition is to ensure that they can make a real and lasting impact on the lives of young people across the county, ensuring that their voices are not only heard, but acted upon.
