## **WORCESTERSHIRE COUNTY COUNCIL (A38 WESTLAND ROUNDABOUT, A38 ROMAN WAY AND C2255 KIDDERMINSTER ROAD, DROITWICH) (30 MPH SPEED LIMIT) ORDER 2024**

Worcestershire County Council in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order: -

1. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 30 miles per hour along those roads specified in the Schedule to this Order.
2. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
3. This Order may be cited as Worcestershire County Council (A38 Westland Roundabout, A38 Roman Way and C2255 Kidderminster Road, Droitwich (30 MPH Speed Limit) Order 2024 and shall come into operation on 19 December 2024.

## Description of the map

The map shows the 30 mph speed limit zone on A38 Westland Roundabout, A38 Roman Way and C2255 Kidderminster Road, **Droitwich**:

**A38 Westland Roundabout** - For its entire length

**C2255 Kidderminster Road** – From its junction with A38 Westland Roundabout for a distance of 75m in an easterly direction.

**A38 Roman Way (southbound)** – From its junction with A38 Westland Roundabout for a distance of 94m in a southerly direction.

**A38 Roman Way (northbound)** – From a point 103m south of its junction with A38 Westland Roundabout to its junction with A38 Westland Roundabout.
