The map shows the Experimental Revocation of Waiting Restrictions zone on Canada Way,

### Worcester: -

**Canada Way (South Side)** From a point 33m west of its junction with Labrador Road for a distance of 39m in a westerly direction.

**Canada Way (North Side)** From a point 30m west of its junction with Labrador Road for a distance of 32m in a westerly direction.
