Map of Crossgate Road, Redditch and the experimental prohibition of waiting zone to be implemented by the above order.

Description of the map

The map shows the experimental prohibition of waiting zone on Crossgate Road, **Redditch: Crossgate Road (Northeastern side):** at a point 12 metres from its junction with upper Crossgate Road for a distance of 10 metres in a southeasterly direction.
(Northeastern side): at a point 46 metres from its junction with upper Crossgate Road for a distance of 15 metres in a southeasterly direction.
