#### **Description of the map**

The map shows the proposed prohibition of waiting zone on Shireland Lane and Lily Green Lane Junction, **Redditch**:

<u>Shireland Lane</u> (Northside) - for a distance of 10 metres from the junction with Lily Green Lane in a westerly direction;

**(Southside) -** for a distance of 10 metres from the junction with Lily Green Lane in a westerly direction.

<u>Lily Green Lane</u> (Northeast side) - from a distance of 5 metres from the junction with Shireland Lane in a northerly direction:

(Southeast side) - for a distance of 5 metres from the junction with Shireland Lane in a southerly direction.
