Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984

WORCESTERSHIRE COUNTY COUNCIL (WYRE FOREST DISTRICT - KIDDERMINSTER AREA) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2004 (VARIATION) ORDER 2025 [EXPERIMENTAL REVOCATION OF WAITING RESTRICTIONS ON SUTTON ROAD, KIDDERMINSTER]

Description of the map

The map shows the Experimental Revocation of Waiting Restriction zone on Sutton Road, Kidderminster:

Sutton Road Kidderminster (West Side) From its junction with Poplar Road for a distance of 31m in a northerly direction.

Sutton Road Kidderminster (East Side) From a point 31m north of its junction with Poplar Road for a distance of 40m in a southerly direction
