

# **Order and Plan for Various Roads, Catshill**

## **Statement of Reasons for proposing to make an Order under the Road Traffic Regulation Act 1984**

### **(VARIOUS ROADS, CATSHILL) (RESTRICTED ROADS AND 40 MPH SPEED LIMIT) ORDER 2002 AND (VARIOUS ROADS, CATSHILL) (PROPOSAL AND REVOCATION) (30 MPH AND 40 MPH SPEED LIMIT) ORDER 2025**

Worcestershire County Council propose to make this Order for facilitating road safety by avoiding danger to persons or other traffic using the road or any other road and preventing the likelihood of any such danger arising.

It is considered that the Order will contribute to the securing of the expeditious, safe and convenient movement of all traffic (including pedestrians) and will have no adverse effect on other considerations contained in s122 Road Traffic Regulation Act 1984

# The order under the Road Traffic Regulation Act 1984

## **WORCESTERSHIRE COUNTY COUNCIL (VARIOUS ROADS, CATSHILL) (RESTRICTED ROADS AND 40 MPH SPEED LIMIT) ORDER 2002 AND (VARIOUS ROADS, CATSHILL) (PROPOSAL AND REVOCATION) (30 MPH AND 40 MPH SPEED LIMIT) ORDER 2025**

Worcestershire County Council in exercise of their powers under Sections 82,83 and Section 84 of the Road Traffic Regulation Act 1984 (which said Act is herein after referred to as 'the Act of 1984') and Part IV of Schedule 9 to the Act of 1984 and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. That The Worcestershire County Council (Various Roads, Catshill) (Restricted Roads and 40 mph Speed Limit) Order 2002 is hereby revoked in its entirety.
2. No person shall drive or cause to be driven any motor vehicle at a speed exceeding 30 miles per hour along those roads specified in Schedule 1 to this Order.
3. No person shall drive or cause to be driven any motor vehicle at a speed exceeding 40 miles per hour along those roads specified in Schedule 2 to this Order.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
5. This Order may be cited as Worcestershire County Council (Various Roads, Catshill) (Restricted Roads and 40 mph Speed Limit) Order 2002 and (Various Roads, Catshill) (Proposal and Revocation) 30 mph and 40 mph Speed Limit) Order 2025 and shall come into operation on XXXXX 2025.

## **Schedule 1**

Lengths of roads in the Parish of Catshill, in the District of Bromsgrove, in the County of Worcestershire subject to the provisions of Article 2 of this order.

### **U21423 (Alvechurch Highway)**

From its junction with U21425 (Birmingham Road) for a distance of 350 metres in an easterly direction.

### **U21512 (Staple Flat)**

From a point 110 metres northeast of its junction with B4096 (Old Birmingham Road) for a distance of 150 metres in a north easterly direction.

## Schedule 2

Lengths of roads in the Parish of Catshill, in the District of Bromsgrove, in the County of Worcestershire subject to the provisions of Article 3 of this order.

**B4091 (Stourbridge Road)**

From a point 125 metres north of its junction with Keith Winter Close in a northerly direction to a point 170 metres south of its junction with C2062 (Rocky Lane).

### Description of the map

The map shows the proposed extension of 30 mph Speed Limit and update of 40 mph Speed Limit on Various Roads, **Catshill:**

**B4091 (Stourbridge Road):** from a point 125 metres north of its junction with Keith Winter Close in a northerly direction to a point 170 metres south of its junction with C2062 (Rocky Lane).

Worcestershire County Council in exercise of their powers under Section 82(2) and 83(2) and 84(3) of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as 'the Act of 1984') and all other powers them enabling in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. The lengths of roads specified in Schedule 1 to this Order shall become restricted roads for the purpose of Section 81 of the Act of 1984;
2. No person shall drive or cause or permit to be driven any motor vehicle at a speed exceeding 40 miles per hour along that part of B4091 (Stourbridge Road) from a point 85 metres north of its junction with UC21000 (Perryfields Road) in a northerly direction to a point 170 metres south of its junction with C2062 (Rocky Lane)
3. This Order may be cited as Worcestershire County Council Various Roads Catshill Restricted Roads and 40 MPH Speed Limit Order 2002 and shall come into operation on 28 January 2002.
