At the LD and Autism Programme Board, Expert Members spoke about top tips for Social Workers, and the Board asked if the Hereford Social Care Team have access to the document. Expert Members said in the spirit of sharing they would be happy to share this document with Hereford. Fran said the more collaboration the better so happy to share.

Young people engagement. Fran asked if this means there is going to be more expert members joining SpeakEasy. Gail explained that young people are increasingly not wanting to come to face to face meetings, most young people want to do the meetings online. Gail said SpeakEasy are hopeful this means there will be more young people joining meetings but in a hybrid way as this will work better for young people.

How does the work in health feed back to the LDPB?

Fran explained to the Board we wanted an item on the agenda to talk about feedback loops into the Board with health colleagues.

Carers are feeling like there are fewer opportunities to feedback. Barbara said carers have not met with health (via Staying Healthy) for a long time and it would be useful to start the meetings in some capacity.

Fran suggested that a small number of the Board meet with health to plan how they will feed into the Board. This could be via a brief Highlight Report which summarises key LD Health issues and actions.

The joint LDPB was a really useful meeting where lots of health colleagues attended. However, the joint LDPB are not part of our formal governance process, it is good meeting twice a year but the Worcestershire LDPB really do need a health representative in attendance.

Annual update on LD Strategy

Fran went through a presentation updating the Board on how the first year of the LD Strategy has gone. The Board looked at each theme:



Theme 1 - A Place to Live, a Home – Some good progress has been made this year. There has been lots of planning for college leavers and there have been housing videos added on the Local Offer Page. Chris and Adam are going to work together about the Shared Ownership Group.



Adam is going to give an update on the actions within the Year One Plan and send to Aimee who will update the Year One Action Plan.



Theme 2 - Communities which include everyone

Fran and Barbara are working on planning the event for the 30th June and this will be added as completed on the Year One Action Plan.

Sam told the Board that Expert Members have been working with Jo Stevens to make the website more accessible for people with Learning Disabilities.

Numbers are increasing at Speakeasy and the team are starting to hear more local issues.

Sam told the Board that Expert Members have been doing pop up groups within day care settings and he was very surprised how many people have never head of SpeakEasy even though the organisation has been running for 20 years now.

Jill said SpeakEasy should be promoted on the Local Offer Website. Gail is going to link up Jill with Morag and Laura.

The Board discussed how unfair it was not being able to use bus passes before 9.30am, this means people cannot go about their day if they rely on these passes to get to work, education, day opps. This issue needs to be raised at the Active Travel Stakeholder Group.

Gail to said there is a petition being circulated to try and get the hours of use for the bus pass changed and Gail will send the link round to the group.



Theme 3 - Purposeful Days. Fran and Aimee are going to meet with Chris Jordan to support with restarting the employment group, this group will link in with employers. Chris is having a meeting on 14.05.24 to progress and will update the Board.

The Supported Employment Team have a lot of positive news stories and communications that have been shared through County Council channels.

The uptake of Supported Internships has been really positive. Jill said at the moment she is looking at what the internship offer is for next year and which providers they will be working with. Most of the students are coming from HoW College instead of Regency. There are already 12 individuals coming through for next year's internship.



Theme 4 – Being Healthy Body and Mind

The joint Herefordshire and Worcestershire Learning Disability Partnership Board was a really good meeting. There has been an uptake on the Health Action Plans, and these have increased.

Expert Members of LDPB are involved in the Healthy Lifestyles work. Adam said he is working with Rachael Skinner about the training to help people who support people with Learning Disabilities and this training information will be going on the ICS Academy. Laura said the LD Assurance Boards are a good example of what has gone well as we are meeting and talking more.

Oliver McGowan Training ("OMT") is going really well. Sam said he is enjoying delivering the training and has had some really positive feedback. Fran asked if we could we get some impact examples from providers who have done the training so we can receive feedback.

Laura said that examples from providers have been asked for at the Programme Assurance Board, however, the presentation was about training and the feedback was just about health settings. We have asked how many people have been on training, they have said they will provide this. Laura said she will feed the update back to the Board.

Pam said she was shocked at some of the questions that are being asked at the OMT sessions. One question was 'I am led to believe by a doctor that learning disabilities can be cured'? Pam said this shows just how much the training is needed. Pam said notes are being made about what questions are being asked and this question was noted.

The Board asked if Rachael Skinner could give an update on progress on the LeDeR Programme?

The Board asked if Richard Naylor could give an update to his actions on the Year One Plan.



Theme 5 – Life Changes

Jill has been doing lots of work on the Local Offer to give info to young people and families about what will be on offer when transitioning into adulthood.

Planning for the Future information – this is a number of years out of date so this is going to be updated. This is an ambition that we have to get updated, but this is moving quite slowly due to pressure of other priorities.

Pam said the events in Worcestershire about transitions (Life Beyond School) are great. Pam said could we move it up to the next level to talk about housing, wills, estates etc?

There has also been a housing video produced explaining what housing options are for families, so work has been done.

Theme 6 - Being Safe.



SpeakEasy held a Managing Risk Event, this was a very well attended event. Links have been made with the fire service.

Fran said she went to a community safety meeting and there is a lot going on there with the police and what funding is available.

Charter around Mental capacity and people having more of an understanding - Fran is going to follow up with Bridget to make sure we have the links.

Theme 7 - Right Support for Family Carers.



We are focused on having more carer reps for people with learning disabilities. Gone well: support for carers from Council point of view, respite services and making sure we have the right provision.

Specific actions for Year 2 action plan to be determined.
